Message from CPF Executive Director

The California Preservation Foundation is a statewide network of more than 15,000 advocates, professionals, elected officials, business leaders, and volunteers who work to preserve California's architectural and cultural heritage. This year we celebrated our 40th anniversary by leveraging the support of our members to push for action, share information, and prepare for the future of preservation.

We **pushed for preservation action** by advocating to save the Historic Tax Credit and pass the Historic Tax Credit Enhancement Act, supporting a National Historic Trail designation for Route 66, and advocating for an increase to the Historic Preservation Fund.

We worked to **prepare preservationists for a changing climate**, hosting the first convening of Keeping History Above Water on the West Coast, and partnering with Office of Historic Preservation and others on the Climate Heritage Mobilization at the Global Climate Action Summit.

We **introduced new audiences to preservation**, launching a student membership and taking hundreds of people from around the world on biweekly rooftop tours of San Francisco's architectural and cultural history.

We **shared our expertise** with others, discussing preservation advocacy and technology with delegates from the Egyptian Ministry of Antiquities, and meeting with Asian and Pacific Islander Americans in Historic Preservation (APIAHIP) to help plan their bi-annual conference.

Advocacy Highlights

This year CPF issued more than a dozen Advocacy Alerts, calling on our members to take action in support of historic places. From a Neutra designed house in Pebble Beach and water towers in Chico, to legislation in both Sacramento and Washington D.C., our Advocacy Alerts have kept our members informed about urgent preservation matters.

Connecting Communities

Over the past 40 years, CPF has firmly established our role as the leader in statewide education and advocacy. By utilizing the power of a growing online presence, coupled with our ability to quickly connect people in all corners of the state, we are helping communities who face vexing preservation issues. In July we asked our members for advice and assistance in preserving Chico's historic water towers, after more than a year of advocacy from the Chico Heritage Association (CHA). More than a dozen CPF members reached out to help and, according to CHA member and CSU Chico Professor Michael Magliari, the responses they received "were very valuable and much appreciated! It was great to hear from people in other communities who had worked to save their own local water towers and who had good advice and information to share with us!"

Supporting Local Action

We leverage our network to bring statewide attention and support for the places that matter to communities across California. This year we wrote letters in support of an economic benefits study of historic preservation in Los Angeles, an expanded nomination of the US Naval Hospital Corona to the National Register of Historic Places, local designations for Rancho San Carlos and two historic districts in San Diego, increased funding for the restoration of San Francisco's Old Mint – and more.

Education Highlights


This year we provided training and information to more than 1,500 people at nearly 90 events, from our conference in Palo Alto to workshops around the state.

Sharing Hidden Histories

Our educational programs bring hidden stories to life, and share the message of preservation with new audiences from around the world. Last October we took 30 people on an exclusive, full-day tour of the Sacramento-San Joaquin Delta. The sold-out tour looked at the area through the lens of the sites associated with Asian Pacific Islander heritage, including the Bing Kong Tong Building, Miyazaki Bathhouse, the Walnut Grove Gakuen, and Locke's historic Boarding House. We also launched a bi-weekly tour of San Francisco rooftops, where we discuss the city's architecture, cultural heritage, and importance of preservation.

Investing in the Future

This year we made two significant investments in students, paving the way for the next generation of preservationists. In April we launched a student scholarship competition, providing educational funds for people pursuing a career in preservation. This year's winners, Kelsey Kaline and Mayela Caro, were chosen from a pool of well-qualified applicants, and we are excited to grow and expand the impact of this program. We also launched a new free student membership program, with nearly 50 people participating so far.
